

目的 Objectives

香港特區政府於2025/26財政年度再投入港幣1億元，延續新一輪清潔生產伙伴計劃兩年至2027年6月30日，以協助位於香港及廣東省的港資廠商採用清潔生產技術，以綠色技術改造提升傳統產業，減排節能，降低生產成本，及改善區內環境質素。

The HKSAR Government allocates another HK\$100 million in the 2025/26 fiscal year to extend the new round of the Cleaner Production Partnership Programme for two years until 30 June 2027 to assist Hong Kong-owned factories in Hong Kong and Guangdong Province to adopt cleaner production technologies which aims at upgrading their traditional industries with green technologies, reducing emissions and energy consumption, reducing production cost, and improving quality of the environment in the region.

申請資格* Eligibility*

任何香港公司** Any Hong Kong business**

- 在香港設立工廠；或
operating a factory in Hong Kong ; or
- 在廣東省設立工廠，其經營方式可為獨資、合資或「三來一補」；或
operating a factory in Guangdong in the form of sole ownership or joint venture or "three forms of processing and assembly operating or compensatory trade" ; or
- 其中一位主要股東為香港居民（自然人）並同時為在廣東省運作的一家工廠的主要股東
with its major shareholder being a Hong Kong resident (i.e. natural person) who is also a major shareholder of a factory in Guangdong.
